

PRIVACY POLICY AND INFORMATION ABOUT COOKIES

Information about Cookies on the Website:

We use our websites to store and access information ('cookies') found on the User's device in order to adjust our services and products to the User's individual requirements. The User may specify the conditions for storing or accessing cookies by using settings in the software installed on the User's end device, e.g. a web browser.

Our Privacy Policy is in place to respect the privacy of the Users of our websites.

Privacy Policy

This Privacy Policy sets out the rules for the processing and protection of personal data obtained from the Users when they visit the AfterMarket.pl website, located at the web address www.aftermarket.pl, (hereinafter the "Website"), provided by AFTERMARKET.PL LIMITED with its registered office in Cyprus at the following address: Chytron 3, Office 301 P.C. 1075 Nicosia, Cyprus, entered into the Registry of Companies maintained by the Minister of Trade, Industry and Tourism under number HE 245422.

"User" within the meaning of the Privacy Policy is a natural person using the Website.

By using the Website, the User accepts the terms and conditions set out in this Privacy Policy.

Personal Data

Pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data (the "Regulation") MICHAU ENTERPRISES LIMITED with its registered office in Cyprus at the following address: Chytron 3, Office 301 P.C. 1075 Nicosia, Cyprus, entered into the Registry of Companies maintained by the Minister of Trade, Industry and Tourism under number HE 245422 (referred to in the Privacy Policy as "AM"), informs that it is the controller of personal data provided by the User in connection with or while using the Website. Personal data is processed in accordance with the Regulation, and in cases required by its content, with the consent of the User.

AM collects only data necessary to conclude an agreement and provide the service chosen by the User, answer questions addressed to AM, market its services and provide information about its offer.

During the registration or ordering a service, AM collects data provided by the User in the website forms or provided by User's Internet browser. This data includes:

1. surname and first name,
2. e-mail address,
3. address of residence or registered office,

4. address for correspondence,
5. telephone number,
6. payment data (including bank account number and abbreviation of the credit card number),
7. Internet address and Internet browser identification,
8. Information about placed orders, performed transactions and managed domains.

In cases required by the provisions of the Regulation, the User consents to the processing of his/her personal data in electronic form, by checking the appropriate box during registration or another procedure aimed at enabling the use of the Website. The User may at any time withdraw his/her consent to the processing of personal data.

Providing data marked on the Website as required is voluntary, but necessary to conclude an agreement and provide the service to the User or to register the User on the Website. If the User does not provide the required personal data, it will not be possible to register the User on the Website or to conclude an agreement and provide the service to the User.

AM shall process the personal data provided by the User in order to perform an agreement and to take necessary steps at the request of the User prior to entering into an agreement (Article 6(1)(b) of the Regulation). In the case of marketing of its own services and sending by AM information about its offer to the e-mail address provided by the User, the basis for processing the User's personal data is the pursue of the legitimate interests of AM (Article 6(1)(f) of the Regulation). Data processing for the purpose of AM providing information about its products and services enables the User to obtain information about the current offer. In the case of providing the Newsletter to the User, the basis for data processing is the User's consent (Article 6(1)(b) of the Regulation), which the User may withdraw at any time.

The User's personal data will be stored in a form allowing identification of the User no longer than it is necessary for the purposes for which the personal data is collected and processed in accordance with the law. The personal data will therefore be kept for the period necessary to perform the agreement and provide the service chosen by the User. After this time, the data will be processed for the period necessary to resolve any potential disputes that may arise in connection with the services provided, e.g. related to claims (this period will include the limitation period for claims under the agreement, in accordance with applicable regulations).

Entrusting Personal Data

Entrusting the processing of the User's personal data or other data referred to in the Privacy Policy may take place on the basis of a written agreement concluded in accordance with the provisions of the Regulation with entities providing AM with such services as hosting, administration, maintenance and management of the Website.

AM entrusts the processing of the User's personal data or other data referred to in the Privacy Policy to other entities providing services directly to AM to the extent necessary to execute orders placed through the Website, based on a written agreement concluded in accordance with the Regulation. If the User uses electronic payments or payment cards, the Controller may provide the User's data to a selected entity processing the above payments on the Website.

Subject to the above provisions, the collected personal data will not be disclosed to any other persons or institutions, unless it is required by applicable law or it is necessary to achieve the purpose of personal data processing and a relevant agreement is concluded to guarantee the protection of the User's rights and privacy.

Rights and Obligations of the User

The User has the right to access his/her personal data and the right to request supplementation, updating, transfer, limitation of processing or rectification of the personal data, temporary or permanent suspension of its processing or its deletion if incomplete, out-of-date, untrue or has been collected in violation of the law or they are no longer needed to achieve the purpose for which it was collected.

In the case of the processing the User's data for the purpose of marketing of its own service and products, the User may at any time submit a written and justified request to cease processing of his/her data due to his/her special situation or to object to the processing of his/her data for such purpose.

AM enables the User to delete his/her personal data from the data set at the request of the User or pursuant to the provisions of the Regulation.

AM may refuse to delete personal data if the User has violated the Terms of Website Use or applicable law, and the retention of the personal data is necessary to clarify the circumstances of the breach and determine the User's liability.

If the User places any personal data of other persons on the Website (including their first name, address, telephone number or e-mail address), he/she can do so only if he/she does not violate the applicable law and personal rights of such persons.

Additional Information about Cookies:

Cookies are text files that are saved on the disk of the User's terminal device, used to recognize the User's device when re-entering the website using cookies.

Cookies are not used to establish the User's identity, but they allow more precise defining of the individual needs of the User who uses the given device and thus offering better services which are more tailored to his/her requirements, as well as facilitating connection with websites of interest to the User.

AM uses cookies also for the following purposes:

- statistical – which allows preparation of statistics on the operation of websites and visits of the Users, for internal and contractors' purposes,
- presentation and personalization of marketing messages displayed on a given terminal device.

The User does not have to allow the installation of cookies on his/her terminal device. To do this, the User must set the web browser to disable cookies so that they are not downloaded and stored on his/her device. Major browser providers offer information about methods of disabling the download and storage of cookies.

Removal of cookies may result in also disabling certain functionality and features of AM websites.

Other Data

In some cases, AM collects certain types of information automatically when the User visits the Website or via e-mail addresses. Such operating data related to the use of the Website (IP address and port, the browser ID, addresses of websites visited) are stored in an aggregate and anonymised form, and are not provided to third parties. This data is used to better understand and improve the Website's operation, functionality and performance, and to generate statistics that will help us to administer the Website.

AM also processes the Users' data for automated processing in the form of profiling. Profiling means any form of automated processing of personal data by AM involving the use of the Users' personal data to evaluate certain personal aspects, in particular to analyse or predict aspects concerning preferences, reliability, behaviour, location of the Users. Each User has the right to object to profiling by AM if he/she believes that profiling violates his/her rights and freedoms, unless the Controller demonstrates that its interest overrides the rights and freedoms of the data subject. The Person to whom services are supplied has the right to object to profiling free of charge in any form by means of available channels of communication with AM.

Data Security

In order to secure the User's personal data against unauthorized access, collection by an unauthorized person, processing in violation of applicable laws and change, loss, damage or destruction, technical and organizational measures are applied to ensure that the processed personal data is protected appropriately to the risks and categories of data protected.

In particular, the Controller uses technical means to prevent unauthorized persons from acquiring or modifying data. The Controller protects the data sets against unauthorized access, ensures access to the User's account only after authentication with the use of an individual login and password. In addition, the data provided by the User when completing and submitting internet forms is encrypted by the use of SSL certificates.

Contact

The Website User may contact AM at any time to obtain information on whether and how AM uses or intends to use his/her personal data and to report any events affecting the security of information and data transmission. AM reserves the right to amend the Privacy Policy and at the same time ensures that the rights of the User arising out of this document will not be restricted without his/her consent. Any amendments to the Privacy Policy will be published on the website www.aftermarket.pl.

Contact with Supervisory Authority

In all matters related to the processing of the User's personal data and the application and implementation of this Privacy Policy, the User has the right to lodge a complaint with the President of the Office for the Protection of Personal Data.
